### **George S. Allayannis**

Allayannis is former associate dean of Darden's Global Executive MBA (GEMBA) program. He is an expert in corporate finance, risk management, financial institutions, and international finance.

### **Jacqueline M. Arthur-Montagne\***

Before entering the academy, Bamzai was an attorney-adviser in the Office of Legal Counsel of the U.S. Department of Justice, and an appellate attorney in both private practice and for the National Security Division of the Department of Justice. Earlier in his career, he was a law clerk to Justice Antonin Scalia of the U.S. Supreme Court and to Judge Jeffrey Sutton of the U.S. Court of Appeals for the Sixth Circuit. He is a graduate of Yale University and of the University of Chicago Law School, where he was the editor-in-chief of the law review.

Konnoth has also served as a deputy solicitor general with the California Department of Justice, where his docket primarily involved cases before the U.S. Supreme Court, and also before the California Supreme Court and the Ninth Circuit Court of Appeals. His cases involved the contraceptive mandate in the Affordable Care Act, sexual orientation change efforts, Facebook privacy policies and cellphone searches. He is also working on a book project with Andrew Stone on how Americans view principles of judging and how elites communicate about these principles to the public.
